


Vocational Rehabilitation



Vocational Rehabilitation programs help people with disabilities train for and find work.

Q: What is Vocational Rehabilitation?

Funded by the U.S. Department of Education and administered by every state, vocational rehabilitation programs offer people with disabilities an array of employment-related services, including career counseling, on-the-job training, education and job placement.

Q: Who is eligible for Vocational Rehabilitation?

People who receive Social Security Disability Insurance or Supplemental Security Income

are generally eligible for Vocational Rehabilitation. To find out if you are eligible, contact your local Vocational Rehabilitation program. Q: What services might be offered through Vocational Rehabilitation?

Vocational rehabilitation services vary by state, but may include:

- Career counseling
- Resume preparation and interview coaching
- Job search and placement assistance
- Technical skills training
- Assistive technology evaluation and referrals
- Benefits counseling
- Medical assessment and services
- Mental health counseling to support job retention
- Hearing aid purchases
- Vehicle and home modification grants
- Long term follow-up and support services

Q: Do Vocational Rehabilitation programs pay for assistive technology or vehicle modification services?

In many cases, yes. If assistive technology or vehicle modifications are deemed necessary to support an individual's employment goals or success, then state programs will often provide financial assistance.

Q: Are young people with disabilities eligible for Vocational Rehabilitation programs?

Yes. In many states, students with disabilities can use Vocational Rehabilitation services to plan for life after high school. Vocational rehabilitation counselors work with families, schools and community partners to help students gain knowledge and experience that supports future employment and independent living.

Q: Are there veteran-specific Vocational Rehabilitation programs?

Yes. The Veteran Readiness and Employment (VR&E) program, sometimes called Chapter 31, provides education, training and job placement for veterans with service-related disabilities.

VR&E employment coordinators can help eligible individuals start their own business, retrain for different careers or access supports to return to their former jobs. Independent living and home adaptation grants may also be available.

Q: What is the American Indian Vocational Rehabilitation Services?

The American Indian Vocational Rehabilitation Services (AIVRS) program, established under the Rehabilitation Act of 1973, provides grants to governing bodies of Indian Tribes to develop training and work placement initiatives for people with disabilities living on or near federal or state reservations. The goal of AIVRS, like state-run Vocational Rehabilitation programs, is to help people with disabilities prepare for and find employment that will increase opportunities for economic self-sufficiency.
