

Team Reeve Terms & Conditions for the 2026 TCS New York City Marathon

Entry Fee & Fundraising Requirements

The Team Reeve New York City Marathon Minimum Fundraising Requirement is \$6,000 regardless of date of registration and the participant is required to pay the New York City Marathon race entry/registration fee. It is the expectation of all team members to continue fundraising even if they exceed their fundraising commitment before the marathon. Team Reeve fundraising pages will list a minimum of \$7,000 on the page to encourage donations over the \$6,000 fundraising minimum. Fundraisers are encouraged to raise their goals higher once they exceed their minimum. The fundraising deadline is October 26th, 2026 unless otherwise stipulated by Team Reeve manager and agreed to by participant in writing. In the event the participant does not meet the minimum fundraising requirement by the date outlined above, the Christopher & Dana Reeve Foundation will charge the balance owed to the participant's credit card. We accept Visa, MasterCard, American Express and Discover. Credit cards will not be charged if fundraising minimum is met. If the card is declined, the participant must provide a new form of payment. If participant does not fulfill their requirement, they will be canceled from the event and reported to the World Major Marathon organization which could result in a ban from other World Major Marathons.

Participant will complete the below steps to be fully registered on Team Reeve:

1. Participant must set up custom Team Reeve fundraising page via GoFundMe Pro fundraising platform within in 3 days of receiving instructions from the Team Reeve Manager.
2. Participant must complete separate 2026 NYC Marathon registration link through NYRR to be provided from Team Reeve manager within 3 days of receiving instructions.

Participant is not confirmed on the team until both steps are completed. Failure to complete these steps in a timely manner may result in the participant losing their position on the team.

Cancellation Policy

After official acceptance on the 2026 team, participant will be responsible for raising a minimum of \$6,000 by October 26th, 2026 even if participant chooses to cancel their participation for ANY reason. New York Road Runners allows athletes to defer their registration for injury or other circumstance until October 30th. All athletes must still fulfill their fundraising commitment by October 26th whether they defer or not. Team Reeve does not have the ability to reassign entries to another team member in the event a participant has to cancel their entry after our registration deadline. All team members are required to hit their fundraising minimum regardless of their circumstances.

Donations & Fundraising

Any donations received by the Christopher & Dana Reeve Foundation/Team Reeve will not be returned. Participants must have at least \$3,000 raised by August 1st, 2026 or the Team Reeve manager has the discretion to charge the remaining fundraising balance. If a participant is not regularly communicating their fundraising progress/strategy with the Team Reeve manager, the manager has the discretion to cancel their event entry before the registration deadline and assign to another participant on the Team Reeve waitlist. The Team Reeve manager reserves the right to charge the remaining fundraising balance to a participant if the registration deadline has passed and they have stopped communicating with the team manager or if they have stopped actively fundraising for the event.

In consideration of accepting this entry, participant hereby for themselves, heirs, executors and administrators, waive and release any and all rights and claims for damages they may have against the Christopher & Dana Reeve Foundation, Team Reeve, other foundation consultants and event sponsors for any, and all potential injuries suffered by participant in said event. Participant attests and certifies they are physically fit, will sufficiently train for competition in this event, and a licensed medical doctor can verify their physical condition if needed. Participant grants permission for use of their name and/or photograph or voice in broadcast, telecast, print or any other account of this event. If accepted on the marathon team, participant agrees to collect the required fundraising minimum for the Christopher & Dana Reeve Foundation by stipulated deadline. If participant has not reached the minimum in sponsorship by that date, they will be personally responsible for the balance owed and will ensure their credit card information provided is current and active to charge the remaining balance.
